Important remarks

- 1 The factory is mainly engaged in producing plastic toys, its weekly capacity can reach about 25000pcs per week, the factory representative said most of procedures were made by hand, so they can improve the capacity by recruiting more workers in peak season
- 2 The factory's QC system is very poor:
- (1) without formal quality manual used in this factory
- (2) The factory's representative said that there is 1 QC to spot-checking the raw materials, but inspection instruction not documented, without any relevant records maintained. And no IQC was found during auditing.
- (3) There are 2 IPQC to spot-checking the semi-products, and inspection instruction was documented, relevant records maintained, but the rejected items were not clearly identified, nor segregated with acceptable items.
- (4) The factory's representative said that there is 1 FQC to spot-checking the finished products, but inspection instruction not documented, without any relevant records maintained and there is no rejective products control procedure. And no FQC was found during auditing.
- (5) did not obtain ISO9000 accredition yet

- (1) over time regulation: the factory pay to workers: 150%times for working days;
- 150%times for weekend 150%times for national holiday, *Violated to the PRC labor law—it should be:*150%times for working days;
- 200%times for weekend;
- 300%times for national holiday
- (2) Sometimes there is no 1 day off in seven days, Violated to the PRC labor law—at least 1day off every 7days
- (3) the minimum wage is RMB750/month, *Violated to SHEN ZHEN local payroll requirement—at least RMB900 per month*
- (4) Without any first aid kits in workshop, there was no trained first aid personal available in the factory.
- (5) Fire protect;
 - A. no emergency lights installed above the emergency exit.
 - B. all the extinguishers/hose were not checked monthly
 - C. without any evacuation drills
- (6) It was noted that workers who handling molds were not provided with steel-toed shoes in the injecting section
